SUBJECT: Scale Software System Upgrade and modification of Existing Annual User Support Agreement

---

**RECOMMENDATION:** That the Board authorize the General Manager to Execute a Contract with Paradigm Software for scale house software system upgrade in the amount of \$96,617.50, and modify the existing annual user support agreement for an additional \$2,047 per year.

---

### BACKGROUND

Disposal and commodity sale quantities at the District are tracked by weight. Each vehicle that arrives at the District with solid waste materials for recycling and disposal is weighed at the District's scale house. This weight is used to determine what a customer is charged and to document the transaction for regulatory reporting purposes. In addition, the quantity of sorted Materials Recovery Facility (MRF) commodities that leave the site to recycling markets are also weighed. These weight records are used by operations staff to understand the activities at the District and for regulatory reporting. The current scale software, CompuWeigh 5.0, used by the District to track the inbound and outbound data is provided by Paradigm Software, LLC (Paradigm) was originally issued in 2002.

### DISCUSSION

The District's scale software is due for an upgrade. District staff approached the need for software upgrade as an opportunity to assess other scale system software available in the marketplace. The District's interests were to identify improved features that may have value to the District's operations and the potential for cost savings both in the purchase of software and in the functional use of the software. Staff coordinated with Paradigm and three other software providers to gather pertinent information and to assess the potential benefits and deficiencies of each software product. Staff's assessment of the various offerings resulted in the conclusion that there were no significant benefits to be gained in changing from the Paradigm software. Paradigm's upgraded version (CW6) provides an enhanced user interface for scale staff, improved reporting capability, improved integration with accounting software, and integration with future automated scale systems that the District is evaluating.

### FINANCIAL IMPACT

The approved FY 2018/19 Capital Outlay Plan Budget for the software upgrade is \$90,000. The proposal provided by Paradigm Software for the CW6 scale system software upgrade is \$96,617.50, which is a \$6,617.50 above the 2018/2019 budget amount and will be covered under the \$13.28 million Capital Equipment Budget for FY 2018/19.

The main reasons for exceeding the budgeted amount are 1) a photo and video capture function and 2) an additional user license above the current number of user licenses. Staff recommends that these elements be purchased as part of the software upgrade. One benefit of the photo/video feature is for the scale staff to document 'as-received' materials to support customer billing records. In addition, this feature would also be used by MRF personnel to document 'as-received' materials exposed in the MRF that may not have been visible at the scalehouse and provide justification for changes to customer billing. The additional user license is for this purpose (e.g., MRF personnel use).

The existing annual user support service charge for Paradigm is \$6,945 per year. The proposed software upgrade is a modification to the user support agreement and will result in an increase of \$2,047.50 annually for a total user support services cost of \$8,992.50 per year.

### STRATEGIC PLAN

The scale system software upgrade to maintain and improve an operating system fits under several general policy directives cited in the District's "Pillars of Sustainability" plan.

- People. The software upgrades provide scale staff with the tools they need to do their job. The improved user interface will improve transaction and reporting time and maintain the software system consistent with current computer operating systems.
- Finance. The upgraded software provides greater "up" time thru improved platform stability enabling scale staff to process transactions for customers more reliably. In addition, the upgraded reporting tools will allow staff improved use and access to the transaction data.
- Community. The upgraded scale software will increase customer transaction rates, billing documentation, and will enable the District to improve service to customers.

### CONCLUSION

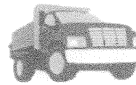
Upgrading the scale software will have multiple benefits to the District's customer and staff. This involves greater uptime, access to data and improved work experience. Staff therefore recommends the Board Authorize the General Manager to Execute a Contract for scale house software upgrade with Paradigm Software for \$96,617.50 and modify the existing annual support agreement for an additional \$2,047 per year.
