SUBJECT: Summary of Personnel Committee Meeting of April 13, 2016

The Personnel Committee met on April 13th at 10:30 a.m., at the District administrative offices. Committee members in attendance were Directors Pendergrass, Downey (teleconference), and Theis. Staff members in attendance were Tim Flanagan, Berta Torres, Chuck Rees, and Becky Aguilar. Deborah Mall from Rob Wellington's office was also in attendance. The purpose of the meeting was to discuss personnel impacts for Fiscal Year 2016/17, and workers compensation coverage for interns and volunteers. Discussion is summarized below and followed the attached agenda.

- 1) Preparation of Preliminary Budget for FY 2016/17. Staff presented information on personnel budget impacts for FY 2016/17 resulting from existing employee agreements, impact of Materials Recovery Facility Improvement Project staffing levels, and additional staffing as discussed and approved at the February 2016 Board meeting.
- 2) Workers Compensation for Interns and Volunteers. Staff reported that while paid interns are considered "employees" and therefore provided workers' compensation coverage, unpaid interns and volunteers are not automatically afforded this coverage. The District has been partnering with California State University Monterey Bay (CSUMB) for several years to provide service learning and internship opportunities for their students. As part of the partnership, CSUMB requires that the District provide workers' compensation insurance coverage to student interns. State law requires that the governing body take action by resolution. Staff will request that the Board adopt a resolution at the April 22nd meeting.
- 3) General Manager Comments. Tim reported that AB 1817 passed the Local Government committee of the Assembly and is proceeding to the Assembly floor. No date has been set, but is expected in the next couple of weeks. It will then move to the Senate for consideration.
