Eligible Organizations

Public agencies, schools, service groups, nonprofits and charitable organizations (and/ or entities holding a fundraising event for these organizations) located within the MRWMD service area are eligible to request special event recycling containers. The MRWMD Service area includes: All coastal communities in Monterey County from Moss Landing to Big Sur, venues in Carmel Valley, and along the Hwy. 68 corridor.

Recycling Containers Available



32 Gallon Blue Plastic Barrels
Has lid with hole for beverage containers. This barrel is good for indoor and outdoor use.



Clear Stream:
Foldable Wire Structure, Holds a 55 gallon clear plastic bag for collection. Removable plastic lid has 3 openings for containers. Good for indoor & outdoor events.



Folding Plastic Boxes:
Color Coded and Labeled for Recycling/ Compost & Trash. Can be used outside, but need weights.

To Request Recycling Containers

To request containers for your event, please fill out the request form that follows and return it to the Monterey Regional Waste Management District office. Prior to your event we will contact you to arrange an appointment to pick-up the containers at the MRWMD facilities. Plans should be made to return the containers within two business days following event. The containers should be returned clean with the same number of pieces returned as given. (There will be a replacement fee charged for any missing or damaged pieces.)
