### NOTICE OF PUBLIC HEARING

NOTICE IS HERBY GIVEN that on June 17, 2022 at 9:00 a.m. or as soon thereafter as the matter can be heard, *which will be held via Zoom*, at the Board Meeting Room located in the District offices at the Monterey Peninsula Landfill, 14201 Del Monte Blvd. (2 miles north of Marina) Monterey County, California, the Board of Directors of the Monterey Regional Waste Management District (District) will hold a scheduled public hearing of the purpose and intent of considering rate changes for the materials listed below, effective July 1, 2022.
