## NOTICE OF PUBLIC HEARING



NOTICE IS HEREBY GIVEN that the Monterey Regional Waste Management District (ReGen Monterey) Board of Directors will hold a public hearing on **May 23, 2025 at 9:00 a.m.** (or as soon thereafter as the matter can be heard) at **ReGen Monterey's Board Room** located in their administrative offices, **14201 Del Monte Blvd.** (2 miles north of Marina off HWY 1), to consider rate changes for the materials listed below, effective July 1, 2025.

| Material  | Current Rate | Proposed New Rate | % Increase |
|---|--------------|-------------------|------------|
| Solid Waste   | \$77.00      | \$81.00           | 5.2%       |
| Construction and Demolition Debris                  | \$77.00      | \$81.00           | 5.2%       |
| Clean Wood  | \$47.00      | \$49.00           | 4.3%       |
| Residential Organics (Yard Trimmings & Food Scraps) | \$47.00      | \$49.00           | 4.3%       |
| Commercial Organics (Food Scraps)                   | \$67.00      | \$69.00           | 3.0%       |
| Single Stream Recycling                             | \$40.00      | \$41.00           | 2.5%       |

\*All rates are on a per ton basis
